### Water Restrictions Resume

Twice per week water restrictions have resumed as of June 27<sup>th</sup>. To our customers in Oak Brook, we are noticing heavy watering early Thursday morning (between 1 am and 5 am), everyone irrigating on the same day can be taxing on our water system. Please take the time to adjust your irrigation systems to follow the year-round watering schedule. Keep in mind that after you make changes to your irrigation timer you should verify that it is following the schedule as expected. Please follow the schedule for your address.

### Park Rules Revisions

The Board of Directors approved new parks rules which include revised fines for rule violations and specifically addresses e-bike use in our parks and green belts, and fishing in the retention ponds on the Oak Brook green belt. New cameras have been installed at the parks to help monitor and prosecute bad behavior in the parks.

Please note that for the safety of kids, rules specific to the playscapes prohibit dogs on the playscapes. And a reminder, all dogs must be on a leash when in our parks.

The Fern Bluff MUD will hold its 2025 Tax Rate Public Hearing on Tuesday, August 26, 2025, 6 pm, at the Fern Bluff MUD Community Center, 7320 Wyoming Springs Dr, Round Rock. The proposed tax rate for 2025 is \$.18/\$100 valuation, a \$.01 reduction from last year's tax rate of \$.19.
