

1. As of this date, the rate of tax levied by the District on real property located within the District is \$0.18 per \$100.00 of assessed valuation.


2. A copy of the Notice to Purchasers as required by Section 49.452 of the Texas Water Code, as amended, is attached as Exhibit "A".

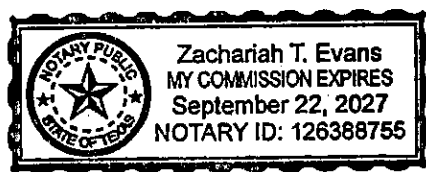

NOTICE TO PURCHASER OF SPECIAL TAXING OR ASSESSMENT DISTRICT

The real property that you are about to purchase is located in Fern Bluff Municipal Utility District ("District") and may be subject to District taxes. The District may, subject to voter approval, impose taxes and issue bonds. The District may impose an unlimited rate of tax in payment of such bonds. The current rate of the District property tax is **\$0.1800 on each \$100** of assessed valuation. The total amount of bonds payable wholly or partly from property taxes, excluding refunding bonds that are separately approved by the voters, are:

\$45,000,000 for water, sewer, and drainage facilities.

The aggregate initial principal amounts of all such bonds issued are:

\$17,315,000 for water, sewer, and drainage facilities.

The District is located wholly in the extraterritorial jurisdiction of the City of Round Rock. Texas law governs the ability of a municipality to annex property in the municipality's extraterritorial jurisdiction and whether a district that is annexed by the municipality is dissolved.

The purpose of this District is to provide water, sewer, drainage or flood control facilities and services, roadways, and parks services. The cost of District facilities is not included in the purchase price of your property.

**PURCHASER IS ADVISED THAT THE INFORMATION SHOWN ON THIS FORM IS SUBJECT TO CHANGE BY THE DISTRICT AT ANY TIME. THE DISTRICT ANNUALLY ESTABLISHES TAX RATES. PURCHASER IS ADVISED TO CONTACT THE DISTRICT TO DETERMINE THE STATUS OF ANY CURRENT OR PROPOSED CHANGES TO THE INFORMATION SHOWN ON THIS FORM.**
